**[D] Functioning Guidelines**

- The association will be managed by the executive council. The executive council contains the representatives from each batch and nominated members by the Head of the department.
- The executive council also includes three faculty representatives nominated by head of the department at the time of meeting.
- The size of the executive council will vary from time to time on the bases of the need and head of the department has sole-authority to decide it. Executive council members will get added/deleted as per the requirement every 2 years. Currently there are 21 (current alumni's) + 4 (current batch students)
- The duration of the executive council is of two years and it begins from the date of first meeting. Dt. of first meeting 17<sup>th</sup> March 2013



- The executive council should meet at least twice a year and it is desirable to conduct one general meeting (all alumnus) in a year.
- The formation of executive council will be done in general meeting only.
- 50 % or more presence is considered quorum, and consent from 50 % or more members (from present members), is considered as approval of the resolution.
- The executive council contains a president, two vice president, one secretary, two joint secretaries and one treasurer. The duration of these posts is of one year but it can be extended till next appointment. Elected persons can be repeated till 2 terms (2 yeras) after that same person cannot be appointed on same post.
- The executive council is primary responsible to alumni only and majority of its programmes should be design with the concern for alumni. It can organize various kinds of programmes with objectives of education, entertainment, union etc.
- All programmes under the banner of executive council should be done after the consent of president and secretary of Alumni Association and finally by head of the department.
- It is advisable to discuss the programmes in the meeting of executive council but in case of urgency president, secretary and treasurer (together) can approve it and in next coming meeting of council it must be discussed and approved. In case of urgency the opinion of members can be taken by email, phone or any other convenient medium.
- About all the programmes the members of the executive council must be informed through email by at least two days before the programme. For informing about any meeting, it is of seven days.
- A programme can be proposed by any alumni. They need to send the proposal to the secretary of the executive council.
- Any alumni who want suggest an idea/event has to fill a pre-defined Performa/format.
- For management of particular programme, from the alumni (irrespective of membership in executive council) a project chairman, a secretary, two joint secretaries, a treasurer and a committee can be appointed. They will act as a sole authority for the particular programme and they will be responsible to only president and secretary of executive council. Appointment of such committee and members should be approved by president and secretary of Alumni Association.
- The executive council is self-finance in nature and it can raise the fund by the ways of sponsorship, entry fees for the programmes, membership fees etc.
- The executive council can ask for assistance in terms of fund or infrastructure from the institute. The final approval for such assistance will be done by the institute's authorities.
- The executive council can have its logo, letterhead, visiting card, stamps etc. But all such material should be approved by the head of the department.
- The executive council members can mention their designation in their personal communications also.
- Any member of Executive council if remains absent in 3 consecutive meeting (for what so ever reason) would get terminated from council automatically and new member would be added to fill the replacement



- In case of any dispute head of the department's decision is considered final.
