# S.V. INSTITUTE OF MANAGEMENT (SVIM) – KADI, REGULATIONS 2009

## TO CONTROL THE THREAT OF RAGGING

#### 1. Title, commencement and applicability:-

These regulations shall be called "SIVM, Regulations 2009 to Control the Threat of Ragging". This Regulation shall come into force with immediate effect.

This Regulation shall be applied within the campus area of SVIM, Kadi(academic, sports, canteen or other places within the S.V. Trust Campus) or outside and to all means of transportation of students provided by SVIM.

#### 2. Objective:-

To root out ragging in all its forms from the Institute by prohibiting it by law, preventing its occurrence by following the provisions of these Regulations and punishing those who indulge in ragging in spite of prohibition and prevention as provided for in these Regulations and the appropriate law in force.


#### 3. Definitions:- (For the purpose of these Regulations)

- 1. "Institute" means S.V. Institute of Management, Kadi
- 2. "Senior" means semester III & IV students
- 3. "Junior" means semester I & II students
- 4. "Ragging" means the following:

Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other student, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

#### 4. Punishable ingredients of Ragging:-

- Abetment to ragging;
- Criminal conspiracy to rag;
- •Unlawful assembly and rioting while ragging;
- •Public nuisance created during ragging;
- •Violation of decency and morals through ragging;
- •Injury to body, causing hurt or grievous hurt;
- ·Wrongful restraint;
- ·Wrongful confinement;
- •Use of criminal force;
- ·Assault as well as sexual offences or even unnatural offences;
- Extortion;
- Criminal trespass;
- Offences against property;
- Criminal intimidation;
- •Attempts to commit any or all of the above mentioned offences against the victim(s);
- •All other offences following from the definition of "Ragging";



### 5. Measures for prohibition of Ragging: -

5.1. The Institute shall strictly observe the provisions of these Regulations of the institute in addition to provisions made by Centre or State Governments, if any, or if enacted, considering ragging as a cognizable offence under the law on a par with rape and other atrocities against women and ill-treatment of persons belonging to any community, and prohibiting ragging in all its forms in SVIM, Kadi.

5.2. Ragging in all its forms shall be totally banned in the entire Institute, all its premises (academic, sports, canteen, other shops etc) whether located within the campus or outside

and in all means of transportation of students provided by SVIM, Kadi.

5.3. The Institute shall take strict action against those found guilty of ragging and/or of abetting ragging.


## 6. Measures for prevention of Ragging:-

## The Institute has to take the Following Measures

- •The SVIM, Kadi shall have an Anti- Ragging Squad to mechanism to provide Institute support for collection of information and monitoring and to co-ordinate with the Institute level for effective implementation of anti- ragging measures.
- •All the employees (faculty, supporting Staffs and Administrative staff) and section of authorities of the functionaries of the Institute shall have the collective responsibility at all levels, and not merely that of the specific body /committees constituted for prevention of ragging for keeping the campus ragging free.
- •The convener of the anti-ragging monitoring cell through convener shall report to the Head of the institute in case any incident taken place in the campus or outside the campus /transportation etc. immediately.
- •Use of mobile phone shall not be allowed in classrooms, seminar halls, Auditorium, Library or other such places as the institute notifies from time to time.
- •The Head of the institute shall be empowered to enhance the student- faculty interaction by involving the students in all matters of the institute, except those relating to the actual processes of evaluation and other administrative appointment etc., so that the students shall feel that they are responsible partners in managing the affairs of the institute and consequently the credit due to the institute for good work / performance is due to them as well.

# Measure for encouraging healthy interaction between fresher's and seniors:-

- •The head of departments shall be responsible to set up appropriate committees during the starting of academic year.
- •Head of the department shall be responsible to organize a fresher welcome partyby the senior students and faculty together soon after admissions, for introduction between senior and junior students and where the talents of the fresher are brought out properly in the presence of the faculty, thus helping them to shed their inferiority complex, if any, and remove their inhibitions.



#### 7. Punishments:-

Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the Institute, the possible punishments for those found guilty of ragging at the Institute level shall be any one or any combination of the following:-

- Cancellation of admission
- Suspension from attending classes
- •Withholding/withdrawing scholarship/fellowship and other benefits
- •Debarring from appearing in any test/examination or other evaluation process
- ·Withholding results
- •Debarring from representing the Institute in any regional, national or International meets, tournament, youth festival, etc.
- •Suspension/expulsion from the hostel
- •Rustication from the Institute for period ranging from 1 to 4 semesters
- •Expulsion from the Institute and consequent debarring from admission to any other institute

Collective punishment: When the persons committing or abetting the crime of ragging are not identified, the Institute shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
